However, if an organisation has an agreement to use standards (without modification) which belong to another body, they can apply for an ISQua organisational survey.

Following entry to the IAP, at any time the organisation can apply for an additional service, e.g. organisational survey.

The IAP service must be taken up within 2 years of entering the Programme or the paid fees will be forfeited.

Non-payment of annual fees following the granting of accreditation will result in accreditation being withdrawn.
